Subject: Our request to intervene for issues at Gujarat-MP check post (Pitol Road)

Respected Sir,

We are an apex body of Transport associations of Gujarat actively working since 1978 and having more than 100 districts and big city associations and around 200 reputed and big transport companies of Gujarat as our members and covering around 10 Lacs commercial vehicles in the State of Gujarat.

Since last 1 year we are regularly receiving representation from various associations as well transporters who are operating between Madhya Pradesh & Gujarat as well passing thru Madhya Pradesh to other states particularly on Gujarat MP border (Pitol Road) regarding harassment as well undue demands while entering Madhya Pradesh.

We are given to understand that on this border every vehicle has to pass thru a weigh bridge and have to pay fees of Rs. 100 and then has to clear thru RTO authorities and have to pay some fix amount (Ranging from Rs 1000 to Rs. 3000) regularly either for a single trip or fixed charges on monthly basis. More surprisingly even empty vehicles have to go thru the weigh bridge and complete the illegal entry payment procedures.

We have earlier also sounded this information thru our counterpart in MP but had no results but after the new ministry under your stewardship has come the expectations of transport fraternity of Gujarat has gone very high and based on various requests received at our body have taken liberty to bring to your notice, such unwanted wrong practices which are demotivating growing business movement between Madhya Pradesh & Gujarat. As a token of proof we have attached herewith 2 live examples of stamped confirmation of illegal settlement based on which the vehicle gets thru passage in Madhya Pradesh.
