Sub.: Protest Dharna by Transport Fraternity of India to highlight non-implementation Clause 6 (b) of Rule 6 of the notified National Highways Fee (Determination of Rates and Collection), Amendment Rules, 2011 (Notification no. G.S.R. 15 (E) dated 12th January, 2011 regarding collection of Toll at 40% at Toll stretches, where either capital cost is recovered or tenure of the concessionaire for collection of Toll is completed, WILL NOW BE HELD FROM 9.00 AM ONWARDS ON THURSDAY, DECEMBER 22, 2022 AT BHAGWADA TOLL PLAZA (VAPI, GUJARAT).

Dear All

This is in continuation to our earlier communications regarding the protest dharna by Transport Fraternity of India at Bhagwada Toll Plaza (Vapi, Gujarat) to highlight non-implementation Clause 6 (b) of Rule 6 of the notified National Highways Fee (Determination of Rates and Collection), Amendment Rules, 2011 (Notification no. G.S.R. 15 (E) dated 12th January, 2011 regarding collection of Toll at 40%.

Due to declaration of elections and implementation of model code of conduct by the Election Commission in the State of Gujarat the Team AIMTC decided to defer the protest dharna that was earlier scheduled for November 18, 2022, to post elections in the State.

We had hoped that the Government would consider and address the legitimate issue raised by the Transport Fraternity in the interest of all road users in the meantime, but it has not happened. Astonishingly, not even a meeting was convened on the subject to discuss the issue related to the subject.

Considering the continual apathy of the Government towards the subject pertinent issue, it is decided that now the protest dharna by Transport Fraternity of India to highlight non-implementation Clause 6 (b) of Rule 6 of the notified National Highways Fee (Determination of Rates and Collection), Amendment Rules, 2011 (Notification no. G.S.R. 15 (E) dated 12th January, 2011 regarding collection of Toll at 40%, **where either capital cost is recovered or tenure of the concessionaire for collection of Toll is completed, will now be held from 9.00 AM onwards on Thursday, December 22, 2022 at Bhagwada Toll Plaza (Vapi), Gujarat.**

You are requested to make it convenient to reach there in large numbers to put up a united show and participate in the protest meet.
