We wanted to discuss the **Six Toll Booths on Baroda-Dahisar stretch** as listed Below :

Our concern today is that at above all the Six Locations the user fee is collected at 100% instead of 40% which is also seen at FAQ on NHAI site as well have attended various meetings at NHAI Head Quarter, New Delhi and MORTH-New Delhi where in various discussions were given to understand categorically that OMT concessioner will be collecting 40% Fees of what BOT concessioner has collected Last.

On further getting in to the subject we found another **four Toll on Palanpur-Radhanpur stretch** where the OMT concessioner is collecting 100% of the Toll value and the concessioner tenure is also over in April 2019. Below listed details are for your ready reference.
