- Sub: Obtain a duplicate of the FIR vehicle arasibuka With respect to the cancellation of the provision
- Ref :- (1) Addl Personal Secretary , Hon. Minister , Transport, Water Supply , labor and employment office , Gandhinagar Letter Number :/PS/ vaa. vy. /shra.ro/.1459 , Dec 21/05/16 paper.
  - (2) Port Tender Owners Association letter given, Honorable Minister Gandhidham, date .04 / 05 / 2016.

With respect to the above subject and reference (1) Kandla tanker Association experienced many difficulties at the time of taking the duplicate RC Book (Smart card) when RC Book is missing.

- 1. The Contentions raised by said association are of follows.
  - (A) Original RC Book remains with checking authority while showing them at Checkpost & at various locations.
  - (B) Driver/Crew takes away Original RC Book at the time of leaving job just to harass the owner of TT,
  - (C) Miscreants takes away Documents from the vehicle alongwith Original RC book whenever Driver/Crew leaves vehicle unattended.
  - (D) Due to negligence of Driver/Crew Original RC Book are misplaced/lost.
  - (E) Other miscellaneous reasons.

- 2. As per prevailing practice for having duplicate RC Book (Smart Card), owner of vehicle has to submit a copy of FIR for the lost of RC Book. Such dealing with the police department, gives rise to corruption. The association suggests that instead of FIR, owner may be allowed to submit an affidavit on Non Judicial Stamp paper duly Notarized narrating the lost of RC Book. This will get relief to vehicle owners from tedious process and will reduce the load from police Department.
- 3. A complaint (Police Report) made to the police station to get the duplicate RC Book is the process as per rule-53 of Central Motor Vehicle Rules-1989. A Police report is required for the duplicate RC Book of vehicle as per the rules. Revocation of this provision and the adoption of a notarized affidavit on non judicial stamp instead of Police Report will facilitate the civilians. So it is requested to change the provisions of rule-53 of the Central Motor Vehicle Rules-1989.

With respect to the above subject and reference many difficulties are being faced by citizen at the time of obtaining duplicate registration certificate, when it was loss or destroyed. It is felt that above stated difficulties required to be removed. Therefor this office proposed to change the rules -53 of the central moter vehicles rules, 1989.
