Order:

The Government is pleased to amend the Home Department Order No. MVR/1004/2063/KH, dated 04/03/2005. In the said order, for the existing paragraph No. 8 which has been previously amended by Ports and Transport Department's order No. MVR/1004/2063/Part-1/KH, dated 31/12/2020, the following paragraph should be substituted:

8. The licensee shall levy a fee for the conduct of the emission test as specified below on issuing a receipt thereof


(a) The test being carried out, under rule 116(1) of the Central Motor Vehicles Rules, 1989 or at the request of the owner or a person in charge of a vehicle for certificate.

Sr. No.	Class of Vehicles	Fee (Rs.)
1	Two wheelers including moped	30
2	Three wheelers (CNG/LPG/Petrol/Diesel)	60
3	Light Motor Vehicles (CNG/LPG/Petrol)	80
4	Light Motor Vehicles (Diesel), all medium & heavy Motor Vehicles (Diesel/CNG)	100

The fee shall include the charges for minor adjustment of the carburetor in the case of petrol driven vehicles.

- (b) in case where the pollution under control certificate cannot be issued for want of compliances of emission standards or when the certificate is not insisted by the owner or the person in-charge of the vehicle, the licensee shall intimate the person in-charge of the vehicle, the emission test result in writing after levying fee specified in para (a) above.
