Circular:

Finance Department has issued the circulars dated 11/11/2016 and 15/11/2016 as mentioned in (1) and (2) above. Government of India, Ministry of Finance, Department of Economic Affairs, vide Notification mentioned at (9) above has extended the time limit upto 15th December, 2016 to the extent of transactions specified below:

- (i) for purchases at consumer cooperative stores operated under authorisation of Central or State Governments up to a limit of Rs.5000/- at a time;
- (ii) for purchase at milk booths operating under authorisation of the Central or State Governments;
- (iii) for purchase of petrol, diesel and gas at the stations operating under the authorisation of Public Sector Oil and Gas Marketing Companies;
- (iv) for making payments in all pharmacies on production of doctor's prescription and proof of identity;
- (v) for making payments on all Toll Plazas on the State and National Highways;

- (vi) for payments on purchases LPG gas cylinders;
- (vii) for making payments to catering services on board, during travel by rail;
- (viii) for making payments for purchasing tickets for travel by suburban and metro rail services;
- (ix) for making payments for purchases of entry tickets for any monument maintained by the Archaeological Survey of India;
- (x) for making payments towards any fees, charges, taxes or penalties, payable to the Central or State Governments including Municipal and Local Bodies;
- (xi) for making payments towards water, electricity charges;
- (xii) For making payments towards purchase of seeds from the centres, units or outlets belonging to the Central or State Governments, Public Sector Undertakings, National or State Seeds Corporations, Central or State Agricultural Universities and the Indian Council of Agricultural Research, on production of proof of identity.
- (xiii) for making payments towards school fees up to a limit of Rs. 2000/- per student in the Central Government, State Government, Municipality or Local Body schools;
- (xiv) for making payments towards fees for the Central Government or the State Government colleges;
- (xv) for making payments towards pre-paid mobile top-up to a limit of Rs.500/- for every top-up;
- (xvi) for making payments at the toll plazas under National Highways Authority of India including concessionaires, with effect from 3rd December, 2016;


Provided that, with effect from 25th November, 2016, for the purposes of all clauses of this paragraph, specified notes shall mean bank notes of the denominational value of five hundred rupees only.

All administrative Departments are accordingly requested to instruct concerned Heads of Departments, PSUs, Municipal and local bodies and other agencies under their administrative control to implement the time limit as mentioned in the Notifications of the Government of India, Department of Economic Affairs.
